12:40 – 12:50 **President's Remarks** – Year in Review – Chuck Cousino (CO), President

- Communication: Website and list serve is our main way to update and communicate. Working on updates and improvements to the site. The website also lists our COI members who provide technical support to our SORA members.
- Bylaws and Strategic Plan are updated and on posted on the website
- NOWRA Mega-Conf. about 20 SORA members attended the conference; Had a successful Tuesday evening event with over 60 attendees; Next year's conference is in late October in Sandusky, Ohio; 2026 conference is in Colorado.
- Lance Gregory is spearheading a new ad hoc committee on onsite funding.
- Looking at kicking off a quarterly or so educational series by the COIs. Allow for more educational opportunities through SORA.



# 12:50 – 1:30 **USEPA Decentralized Program Update** – EPA staff

Zach Lowenstein – SORA is the group that EPA needs to reach in order to get the word out on the Closing America's Wastewater Access Gap Initiative

- Goal is helping communities with failing septic systems or no infrastructure
- Providing technical assistance on options for solutions to those failures
- All options on the table: repair/replace individual onsite systems; cluster decentralized systems; connect to central sewer
- 11 Pilots started in 2022
- New initiative up to 150; currently 31 on boarded now, but about 50 communities overall as some have multiple projects
- Start with an assessment and site visit work with community leaders
- Leads into a solutions plan or a PER Solutions Plan are more a roadmap on how to advance with cost estimates. Funding support to help put together funding applications
- Want to consider long term planning to include management and O&M
- Review of who can quality for this program.
- Selection: must meet criteria for disadvantaged; what is the community need; openness to receiving technical assistance. Many states have no projects yet and EPA would like to be able to spread this out to more communities.
- Request for SORA to help getting the word out. Need more communities.

- Comment: MB has had some issues in the past with no inspection or not going through the proper channels.
- Comment: What's the timing to get into the program? And will the funding change due to election results? Funding is from the Bipartisan Infrastructure Law so it should be pretty safe. This program is for 3 years, so finishes Feb 2027, but need to bring them into the program by Feb 2026 to allow the process to be completed.

# Overview and Updates - Heidi Faller

- EPA Decentralized Team has expanded to a total of 5
- Onsite is not regulated by EPA. The decentralized section was created in early 2000.
- MOU Partnership has grown to 25 partners; reviewed every 3 years
  - Septic Smart Program MOU initiative
  - Provide Technical assistance CAWAG
  - Showcase information and technology
  - o Utilize federal and MOU partners networks to gather onsite data
  - o Expand mechanisms to address workforce, training, research needs
  - Reviewed activities completed in 2024 and priorities for 2025
- Review of analytics from website and contacts mentions up 19%; community outreach; Instagram posts; Facebook; web stories; YouTube videos

National Waste Alliance – National Septage Disposal Issue Jason Birdsong (NAWT) jason@jtserviceco.com (For link to survey contact Jason or nicholas.huber@deq.ok.gov)

Have identified a septage disposal issue in many states coast to coast. Currently preparing a white paper that can go to federal level to highlight issue. Looking at funding – if a municipal WW facility accepts federal funding, then they should have to accept septage.

#### Comments:

- LG (VA) has that requirement, but there is an opt out where an engineer can say they can't take the septage (system can't handle it). JB said he's not gotten that comment before so glad to hear of it. System should have to accommodate septage if they receive federal funding.
- KU (AZ) hearing that wastewater treatment plants are running out of capacity to take septage.
- JB some are pretreating the septage before sending the liquid to the wastewater plant so that's a different and new way to address it.
- CC (CO) wastewater plants are focused on effluent limits so anything that disrupts their compliance is an issue.
- AB (NOWRA) –Tax payers are not getting the services they pay for and then have to deal with illegal dumping, high prices, etc.

- RCAP grant \$800,000 3 year to produce training program Difficult Sites; O&M;
   Community Systems
- NOWRA raised the concern to USDA that many engineers do not consider decentralized as an option due to lack of familiarity – hoping to get approval to do training on this aspect. NOWRA has considered cost savings of decentralized. Focus is how to educate everyone so that they understand all the options.
- 2025-2028 NRWA and RCAP grant opportunities being applied for training (of NRWA); glossary refinement; college level course; RME training; Regulatory course
- New no cost courses on the website for NOWRA members business courses and regulator course

- Secondary safety devices (Inf.); Other items
   Dave Lentz Infiltrator dlentz@infiltratorwater.com
  - Secondary safety devices to prevent accidental drownings
  - Would like to collaborate as an industry and with regulators to address issue
  - Lots of different designs, several manufacturers, low in cost
  - Six states have the standard; Canada has a national requirement
  - Purpose today: to prompt thought and rationale for action
  - Do have model language available that they can share.
  - Having similar terms between states would be helpful.
  - Some think the cost is prohibitive.
  - Mentioned that some O&M providers are adding the devices at no cost to the homeowners just as a precaution.
  - CT put it in 2023 rules, but did not include standards for the device. They were seeing all kinds of homemade systems going in. Had to recently change the definition to include load standard and 3<sup>rd</sup> party testing.
  - VA noted that ideas to make it an integral part of the opening helps to avoid the throw away aspects that we see for other add on systems, like effluent filters.
